

Petition

To the Honourable the Members of the **House of Assembly** in Parliament assembled –

Luke 11:52

Woe unto you, lawyers! For ye have taken away the key of knowledge: ye entered not in yourselves, and them that were entering in ye hindered.

The petition by an individual citizen, a member of a minority group and elector for and of the Greater State of South Australia, contritely draws to the attention of your Honourable House the actual issue of **‘government accountability to the people’** in regards to the peoples: *faith, trust and reliance* of their duly elected members for good governance, professional Standards and due diligence in their performances as public servants, thus in humble acknowledgment, sincere recognition and in light of the following:

TRUTHS

1. Are **‘Not’** the gifts of life, liberty and freedom bestowed upon all mankind by God, equally and before the law, and is it also **‘Not’** by God’s blessed grace the sole, initial and fundamental purpose for the creation of governments to fully protect those his gifts, as mandated specifically and as a duty to the smallest minority groups of our free society being that of the individual.
2. Is the fact that customary prayers are already said in this place at the beginning of each sitting of parliament thus **‘Not’** sufficient evidence that the words of our Heavenly Father and the Almighty Creator are honourably upheld in this house, such as: Psalm 119:165, Deut 4:2, 2 Corin. 3:17, John 15:20, Isaiah 10:1-2 and Isaiah 8:16,20
3. Is it **‘Not’** with the upmost respect, full admiration and conditional of our acceptance that **‘Lest we Forget’** means by eternal vigilance we uphold, as payment for the debt bared by the countless service men & women from *this Great Land of Ours*, who did **‘Not’** turn away, shirk nor step back but honoured the call to defend our way of life against oppressive tyranny for and on our behalf, those that fought, that bled and that gave their lives, alone and on foreign shores, in our defense from the *Imperialist central powers* and the *Axis powers* far from the golden soil we call home.
4. Do we **‘Not’** heed, observe nor honour our contracts, inherited and maintained by birthright of our Regent, **HM the Queen Elizabeth II**, on behalf of **King Edward I**, who sealed into law on the 12th day of October 1297, *‘including but not limited to’* namely the:

Magna Carta,

...given to all the Freeman of our Realm, for Us and our Heirs for ever, these Liberties under-written, to have and to hold to them and their Heirs, of Us and our Heirs for ever... By letters patent..., No judgments are to be given henceforth that are contrary to the Charter –else they be "undone and holden for naught"

Article XXIX (29) *NO Freeman shall be taken or imprisoned, or be disseised of his Freehold, or Liberties, or free Customs, or be outlawed, or exiled, or any other wise destroyed; nor will We not pass upon him, nor condemn him, but by lawful judgment of his Peers, or by the Law of the Land. We will sell to no man, we will not deny or defer to any man either Justice or Right!*

REQUESTS

- A) Your petitioner therefore sincerely, contritely and humbly informs you of his *will* to have your Honourable House move by the appropriate procedures so as the Government take immediate actions to fully reconsider *‘and with reference to the above four(4) Truths’* all the amendments made to the *‘Serious and Organised Crime (Control) Act 2008’* furthermore until completion thereof, grant immediate substantive relief to the many thousands of people whom currently are actually incurring claimable injuries, harm and suffrages as a direct result of stress, pressure and fear associated due to the extreme nature of the enacted amendments of an *‘ultra vires’* concern,
